

24. Correct. The answer is false. After adjusting for inflation $450/0.98 = 459.1837$, $457/1 = 457$, $458/1.03 = 444.660$, we can see that the equipment is cheapest in 2000. This implies the equipment's nominal price has gone up less than the rate of inflation.
