

25. Correct. The answer is true. Let demand in the more inelastic market be D_i and demand in the more elastic market D_e . If costs are distributed across production rather than as a fixed charge, price increases from P_1 to P_2 . Then the loss in consumer surplus in the more inelastic market (yellow triangle) is smaller than the loss in consumer surplus in the more elastic market (green triangle)
