

**20. Correct. The answer is false.** Ring fencing is the separation of the accounts of one activity from those of other activities. In electricity restructuring, it is generally agreed that the competitive sectors should be ring fenced from the natural monopoly sectors in order to prevent cross subsidization from the natural monopoly to the competitive sector.
