

**25. Incorrect. The answer is true not false.** RPI-X refers to a price cap allowing a price increase equal to the rate of inflation minus the target productivity factor X. X is to be reset only every 4 to 5 years. This lag is to encourage utilities to reduce costs, since they would be allowed to keep any savings greater than X.
