

26. Correct. The answer is true. If market prices are to allocate electricity and signal the need for more capacity, they must be allowed to do so. Prices should be varied by time of day to reflect the real level of scarcity. If prices are not to allocate electricity, then some other means must be developed to develop capacity requirements.
