

**3. Correct. The answer is true.** First order conditions require that marginal revenue equals marginal cost as shown in the answer to question 2. Second order conditions require that

$$dMR/dQ - dMC/dQ < 0 \Rightarrow \text{slope MR} < \text{slope of MC}.$$
