

14. Correct. The answer is true. MRP in a competitive market is factor demand and marginal cost is factor supply. By setting the demand and supply equal, we get

$$\text{MRP} = \text{MC}$$

$$100 - 2Q = 2Q$$

$$4Q = 100$$

$$Q = 25.$$
