

27. Correct. The answer is false. They show that we should operate where the rates of return on the two assets are equal to each other on the margin. They also find that along the optimal consumption path, if the marginal utility of produced capital compounded to time t is greater than the discount rate, consumption should be growing; if it is less consumption should be falling. When they are equal we have a steady state.
